WHAT IS 4C?

4C For Children was founded on April 1, 1970 and we are the Child Care Resource & Referral Agency (CCR&R) serving the Kenosha, Milwaukee, Ozaukee, Racine, Washington, and Waukesha Counties in southeastern Wisconsin. 4C offers a variety of services that support quality Early Care and Education. We provide training for existing and new child care providers, help parents navigate the process of child care options available, work closely with the State of Wisconsin regarding the delivery of YoungStar services, and provide a USDA Food Service program for Family Child Care Providers. 4C is recognized as a leader in the field of early education. The Main office is located in Milwaukee, with a satellite office in Washington County.

We continued working towards our two main objectives of supporting Early Care and Education Programs and connecting families to these programs.

The Accreditation Facilitation Project – AFP – is funded through Greater Milwaukee Foundation with an overall goal of supporting 45 programs in receiving accreditation. This project is for both Family and Group child care providers that are interested in achieving accreditation through either NAEYC or NAFCC. The project provides a layer of support such as funding to assist programs with accreditation costs, technical assistance, and strength-based coaching. Any program within the zip codes 53204, 53206, 53210, 53215, and 53218 is eligible to participate. Currently, AFP is working with 22 active programs on their accreditation journey.

Bridges to School Milwaukee is a collaborative project that began implementation in 2022. This project, funded by a grant from the Department of Education through the MPS Community Schools, has two primary outcomes - to connect parents and families to information and resources that support optimal development for young children and to establish connections between parents/ families, Early Care and Education programs, and the neighborhood MPS Community School to create a smooth path to the formal education system. This transitional path includes the areas of social/emotional health, academic readiness, and parent/family engagement, among others. Currently, three MPS Community Schools are the "hub" of this community approach to supporting parents in preparing their children for school readiness.

Behavior Help Wisconsin is a pilot program that helps early childhood care and education providers who feel challenged by the behavior of a child. Behavior Help Coaches provide one-onone coaching to the child's parents/guardians and care provider to equip you with tools, knowledge, and skills to reduce challenging behaviors and promote positive ones. Our evidence-based approach strengthens the social-emotional development of young children as identified in the Wisconsin Model Early Learning Standards.

Partner Up – The Partner Up! Grant Program is part of a larger initiative from DCF called Project Growth, which focuses on public-private partnerships to address child care affordability and access in the state of Wisconsin. In 2022, Partner Up! provided \$10 million in funding to support partnerships between businesses and child care providers, where businesses purchased child care slots at existing regulated child care programs for their employees. Businesses were asked to pay a minimum of 25% of the "true cost of care" for these slots, and the Partner Up! grant paid the remaining 75% cost. Child care providers who participated in the program benefited from the additional funds received from Partner Up!, which allowed them to increase staff compensation, pay expenses, improve the quality of their child care program, and more.

WASHINGTON COUNTY CERTIFICATION

In January 2022, 4C For Children started providing certification services in Washington County. Recruitment and outreach activities are ongoing to increase the number of certified providers in this area. Marketing strategies have included social media advertisements, Facebook group postings, participation in local outreach events, and flier postings in many of the towns and villages in the county.

PATHWAYS TO QUALITY

YoungStar is the primary sponsor for the Pathways to Quality Conference and Resource Fair held in Milwaukee County and provides child care professionals with access to resources and information related to quality child care practices. 225 CHILD CARE PROFESSIONALS ATTENDED THIS HYBRID CONFERENCE.

The MAXIMUS Child Care Subsidy Program (MCCS) supports eligible participants by funding the total cost of care while parents seek work, attend school or training. This program provides subsidies to children birth through 12 years of age. A child with exceptional needs as defined by the State and proven with documentation can be served to age 19. This program has a "parent-choice" policy. The parent selects a regulated program of their choice.
